1. The applicant of the present application is a practicing advocate who had filed a previous writ petition, concerned with the issues which are under consideration herein. By the order dated 20th September, 2016, the application in the WP(C)No.7737/2016 was disposed of giving liberty to the applicant to seek impleadment in the present matter wherein the same challenge has been raised. Therefore, there can be no possible objection to the impleadment of the applicant in the present matter.

2. The applicant is permitted to be impleaded as co-petitioner.

3. This application is allowed in the above terms.

W.P.(C) 1449/2014

1. Mr. Rahul Mehra, Id. Standing Counsel for Government of NCT of Delhi submits that list of matters relating to the different aspects of working of the Tihar Jail, amendments in the Jail Manual and improvement of facilities in the jails in Delhi is ready. He shall place the same before the Registrar (Appellate) in terms of our last order dated 18th May, 2017 and examine whether these cases deserve to be consolidated for hearing at one place.

2. A status report dated 19th July, 2017 (*page 48*) has been filed submitting that system for making and processing an application for on-line visitors is under active consideration and therefore, every effort is made to start the same at the earliest. The status report also informs of the on-line booking system which is already in operation. The status report also informs that so far as prisons in Mandawali and Rohini jails are concerned, they are already equipped with this facility

3. We are informed by Ms. Ritu Kumar, Id. counsel for the petitioner in WP(C)Nos.3146/2012, 4425/2012 and 4588/2014 that the issue of expansion of the board of visitors and notification thereof is pending with the Government of NCT of Delhi. Let this process be completed and the notification be issued within a period of three weeks from today.
