5. According to the petitioner, Ram Bilas Paswan, Anita Paswan and Vicky Mirdha are involved in human trafficking under the guise of R.B. Placement Agency. It is further submitted that number of girls have been lured by the aforesaid persons and W.P.(CrI.)1391/2020 was listed on 03rd September, 2020 in which this Court issued notice for 15th September, 2020 and directed Crime Branch (AHTU) to immediately take up the investigation and produce the missing girl before this Court on 15th September, 2020.

6. Crime Branch (AHTU) is directed to take up the investigation in this case along with W.P.(CrI.)1391/2020 and produce the minor girl, [REDACTED] before this Court on the next date of hearing.

7. If the petitioner has some other lead in the matter, he shall furnish the same to the DCP, Crime Branch (AHTU).

8. The status report be filed under the signatures of DCP, Crime Branch (AHTU) on the next date of hearing. The advance copy of the status report be furnished to counsel for the petitioner at least one day before the next date of hearing.
