1.4. Learned counsels for other respondents are also directed to exchange their respective pleadings amongst themselves so that each respondent is aware of the stand taken by the other respondents.

2. List the captioned matters on 14.04.2021.

3. Interim order dated 31.07.2020, passed in CM No.17447/2020, filed in W.P.(C)No.4834/2020, and interim order dated 27.08.2020, passed in CM No.20586/2020, filed in W.P.(C)No.5697/2020, have continued up-until today.

3.1 Learned counsels for the respondents say they that have no objection to the said interim orders being made absolute during the pendency of the captioned writ petitions.

3.2 It is ordered accordingly.

3.3 CM No.17447/2020 filed in W.P.(C)No.4834/2020 and CM No.20586/2020 filed in W.P.(C)No.5697/2020 are, accordingly, disposed of.
